2017 Summary and 2018 Objectives of Marketing Director Bryan Bishop

While 2017 was a short year for myself (a couple of months) in this position, I have had the opportunity to work with everyone on this Board and am very confident that we can all work well together going into 2018. The fall 2017 BBQ while was a success needs to have a time commitment so that the board, vendors, and members are not wondering when the BBQ will
be and trying to make plans for it. Instead we need to plan around it. If we have asset date i.e.: Weekend after May long or the first week of June, then everyone knows when it is and we plan accordingly, we will not always be able to accommodate everyone but those that want to be there will be there. The same is said for the Fall. These 2 events should be the focus for membership renewal and new members.

I supplied each vendor with a short questionnaire (copy included) and have put together a summary to help answer questions going forward about events such as the BBQ. Included with this summary.

Mr. Jeff McFarlane offered the use of his small but sufficient generator for us to use at the dog park for the BBQ and in the future if this is needed. I took advantage of having this generator and cut the bench in the storage shed to make more room for the larger items. Thanks again Jeff, Jeff also had a new banner made for us and it was put up at St. Anne's road during the BBQ.

Mr. Shawn Bennet has approached me and offered to sponsor a Port-a-Potty for the Park. Our former President had emailed the city of Winnipeg(Jessica) to see what if anything was required for us to move forward with this, there has been no response at this time (Nov 24 2017).

For 2018, my focus is to bring awareness to everyone that uses the park that the board is here for a reason and that we want to listen and improve the park for everyone. The BBQ and AGM attendance are going to be the marking points, membership numbers and vendors (business) involvement in the Park. We are currently working in getting a Port-a-potty in the park. This will be a team effort to come to fruition. The other concern that I have and am hearing about is a yard light in park somewhere. This will become the next issue after the port-a-potty.

I am looking forward to working with this board and hopefully some new members going forward into 2018.

## Report on Special Events for 2017

This is the first report of the Special Events Director as the position did not exist until March of this year.

The MGPDOA held a number of events in 2017. The first was a park cleanup event on February 20, 2017. The event was quite successful as it was a nice day and we picked up an amazing amount of dog waste and other garbage (about a 1,000 pounds but this of course included some snow and ice). We gave a prize for the cleanup (\$25 Tim Horton's card and coffee mug) and that went to Irene Nowostawski. The Board decided to again hold 2 membership events in June instead of a Spring BBQ. Sandy Sexsmith won a welcome dog figurine. The membership drive resulted in approximately 48 new members.

The fall BBQ was held later than usual on Saturday, October 14, 2017 from 10:00 AM to 2:00 PM. Despite the day starting with snow it turned out well with very good attendance. Having hot coffee was no doubt of benefit! The hot dogs went over well thanks to our cooking team. We also had some excellent support from local vendors arranged by our Marketing Director, Bryan Bishop including Aardvark Pets, now Thrive Pet Food Market who supplied our hot dogs and buns (thanks Jeff), Global Pet Foods, Pet Valu, City of Winnipeg Animal Services, Happy Tails Pet Resort and Spa, Central Veterinary Services, Tir na nog and Norway House Animal Rescue, She's Got Leggs, Homeward Bound Pet Food Delivery and Pet Smart.
